#### ARTWORK SUBMISSION FORM

Submission date is Wednesday, March 27, 2024 between 10 am and 6 pm.

Artwork must be submitted ready to display. All pieces that will be hung and are not on canvas, need to be mounted on foam board or matte board cut to the size of the artwork. If your work is on canvas, please make sure it can be hung, i.e., with wire or a hanger. Other work that is sculpture or clay needs to stand on its own or be mounted securely. Remember you want your art to be presented in a manner that shows it off to the judges.

Judging will be by a panel of artists selected from the Elko County Art Club membership. The winner(s) will be notified the day prior to the opening of the Northeastern Nevada Museum (NNM) Exhibition for the Elko County School District.

At least one piece from each Scholarship Applicant will be exhibited at the NNM Exhibition.

The Applicant agrees their artwork submitted in application for the scholarship may be displayed by the Elko County Art Club, subject to policies and provisions in the ARTWORK RELEASE FORM. The period extends from date of artwork submittal until the close of the NNM Exhibition, after which the artist will retrieve their work at Elko County Art Club Gallery, 407 Railroad Street, Elko, NV between 10 am-6 pm on May 14, 2024.
